ORDINANCE 2006- 322

AN ORDINANCE OF THE CITY OF TAMPA, FLORIDA, AUTHORIZING ESTABLISHMENT OF AN AMENDED BOUNDARY FOR THE NEW PORT-TAMPA BAY COMMUNITY DEVELOPMENT DISTRICT; PROVIDING FOR AMENDMENT OF THE BOUNDARIES OF THE DISTRICT BY ADDING ADDITIONAL PARCELS OF LAND THAT WILL BE SERVED BY THE DISTRICT AND TO REMOVE A SINGLE PARCEL OF LAND THAT WILL BE DREDGED AND BECOME SUBMERGED LANDS, WHICH WILL RESULT IN A NET GAIN OF 2.87 ACRES M.O.L. FOR TOTAL OF 54.13 ACRES COMPRISING THE DISTRICT AND SITUATED ENTIRELY WITHIN THE BOUNDARIES OF THE CITY OF TAMPA, HILLSBOROUGH COUNTY, FLORIDA (SAID DISTRICT BEING GENERALLY LOCATED NEAR THE INTERSECTION OF GANDY BOULEVARD AND SOUTH WESTSHORE BOULEVARD); THE AMENDED BOUNDARY BEING MORE PARTICULARLY DESCRIBED IN SECTION 2 HEREOF; PURSUANT TO CHAPTER 190, FLORIDA STATUTES; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the New Port Tampa Bay Community Development District (the "District") was established by City of Tampa Ordinance 2005-233; and

WHEREAS, the District was authorized by City of Tampa Ordinance 2006-38 to exercise certain Special Powers enumerated in Chapter 190 of the Florida Statutes; and

WHEREAS, the District submitted a petition with the City Council of the City of Tampa, Florida (the "City"), a copy of which is on file with the City Clerk, pursuant to the Uniform Community Development District Act of 1980, Chapter 190, Florida Statutes, to adopt an ordinance amending the boundaries of the District; and

WHEREAS, the District published notice of the hearing to adopt an ordinance amending the boundaries of the District at least once a week for four (4) consecutive weeks

10 BE IT ORDAINED BY THE CITY COUNCIL

14 Section 1. That the recitals above are hereby incorporated as if fully set forth
15 herein.

17 Section 2. That the **New Port - Tampa Bay Community Development**
18 **District** boundary is hereby amended, as more particularly described in Exhibit "A"
19 attached hereto.

21 Section 3. That the City Clerk shall record a copy of this Ordinance in the
22 Office of the Clerk of the Circuit Court of Hillsborough County, Florida.

24 Section 4. That all ordinances or parts of ordinances in conflict herewith are
25 hereby repealed.

27 Section 5. This ordinance shall be effective immediately upon execution by
28 the Mayor.
